### Message from the Chairman



The Board of Supervisors is dedicated to improving the quality of life and services for Los Angeles County residents. As Chairman of the Board, I am pleased to report some positive developments coming out of Sacramento. Local government leaders and Governor Schwarzenegger are close to an historic budget agreement that, if enacted by the Legislature, will provide long-term protections for vital local government services in Los Angeles County and cities and counties throughout the State, like police and fire protection, parks, libraries, road repairs and more.

The cornerstones of an agreement would include a two-year budget compromise where local governments would help the State one last time, in exchange for long-term constitutional protection that prohibits the State from ever taking local government funds again in the future.


While these short-term sacrifices would undoubtedly impact us here at home, the long-term protections would provide much-needed fiscal stability at the local level and ensure we can continue funding the critical local services upon which our residents rely.

The Governor has pledged his strong leadership in moving such a package through the legislature, and ultimately helping pass a constitutional reform measure on this November's Statewide ballot that prohibits future State raids of local government tax dollars.

Governor Schwarzenegger has given local government leaders an active seat at the table and we are looking forward to working with him, the legislative leadership, and the entire legislature to solve the fiscal imbalance between State and local government.

## LACERA Elections for Board of Retirement and Board of Investments

Safety Members are encouraged to vote in the upcoming LACERA elections for the Seventh Member and Alternate Member of the Board of Retirement, and the Fourth Member of the Board of Investments. The elections will be held on Tuesday, July 27.

Using the employee's address on the Auditor-Controller's master file, the Registrar-Recorder/County Clerk will mail ballots to eligible safety members via US mail on Tuesday, June 29. If you do not receive an original ballot, you may request a duplicate ballot through your Departmental Election Coordinator no later than Thursday, July 15.

The Registrar Recorder/County Clerk must <u>receive</u> voted ballots before 5 p.m. on Tuesday, July 27. The Board of Supervisors will certify election results at its meeting on Tuesday, August 17.



## Supervisor Burke Attends Unveiling of Inglewood Courthouse Photo Display

Supervisor Yvonne Brathwaite Burke joined officials at the Inglewood Courthouse for the unveiling of a photographic display honoring the diversity of people who have fought for civil rights in the United States. "It is an exhibit of great civil rights heroes, and is the culmination of the Inglewood Courthouse Beautification Project that started two years ago," she told those gathered at the unveiling.

The photographs included one of Supervisor Burke with Los Angeles Mayor Tom Bradley; Rev. Martin Luther King, Jr., being greeted by Supervisor Burke's predecessor, Kenneth Hahn, at Los Angeles International Airport; Robert Kennedy and Cesar Chavez sitting together; Supreme Court Justice Thurgood Marshall; U.S. Attorney for the Central District of California, Debra Yang, being sworn in; the civil rights march on Montgomery, Alabama; and the famous photo of the flag being planted in triumph in Iwo Jima during World War II.

Supervisor Burke noted that she had helped purchase benches, the planting of flowers in the patio, and enlarging and framing of photos for the display, after being approached by Judge Eric Taylor, who at that time was Presiding Judge of the Inglewood Municipal Court.

"I want to congratulate Judge Taylor for spearheading this project," Supervisor Burke said. "It pays tribute to an important time in American history, and I feel very honored to have my photo included in such a collection."

The photographs have been moved to various sites in the courthouse. Supervisor Burke's photograph is in the Jury Room.

# **ENRICHING LIVES...**

Supervisor Molina Celebrates Third Annual César E. Chávez Community Service Week Turnout High; Probation Department Employees Especially Active

upervisor Gloria Molina and thousands of County employees volunteered their services throughout the Southland during the County of Los Angeles' Third Annual César E. Chávez Week, which took place from March 26-31. Molina initially created the "working holiday" to commemorate the life and accomplishments of the legendary United Farm Workers labor leader. Typically, the County celebrates Chávez Week during the week prior to his birthday on March 31.

"I am so pleased that such a large number of County employees continue to participate in Chávez Week each year," Supervisor Molina said. "It's a great way for people to help improve our community while simultaneously paying respect to César. And it's the least we can do to honor a man who dedicated his life to improving basic working conditions for thousands of workers and who inspired millions more to take up the cause."

Approximately 1,783 County employees volunteered their time at various community gardens, beautification projects, food shelters, and beach clean-ups across the county in addition to tutoring sessions at the county's Probation Department camps and libraries. In addition, County employees donated more than 25,737 pounds of food – about 20,590 meals – to needy families via 185 county facilities. Participation in all County departments was commendable but employees from the Probation Department were especially involved this year.

At Barry J. Nidorf Juvenile Hall in Sylmar, the Los Angeles Salsa Dance Company performed a ballet in honor of Chávez. Central Juvenile Hall in Los Angeles hosted a pair of special assemblies featuring the live entertainment of the Ray Sandoval Band. Los Padrinos Juvenile Hall in Downey welcomed inspirational speaker and former boxing Heavyweight Champion of the World Ken Norton.

In addition, staff from the three juvenile halls hosted basketball clinics and life skills workshops for youth at Athens

At Camp Fred Miller in Malibu, staff arranged for a variety of festivities including Montebello High School Folklorico dancers, a special tribute to long-time County of Los Angeles

Commissioner Sybil Brand, and a presentation of poetry authored by youth from the camp who participated in the Dreamyard Los Angeles program.

Camp Glenn Rockey in San Dimas, hosted a program featuring Aztec dancers, live music from D.J. Cardenas, and a video documentary on the life of César E. Chávez by Albert Melena of San Fernando Valley Partnership. Members of Students Against Substance Abuse, the Associated Student Union, Child Development Engineering, and the Administration of Justice Club from East Los Angeles Community College assisted with the festivities.

Camp Kenyon J. Scudder in Saugus featured the Santa Clarita Ballet Folklorico under the direction of Luz Medina, as well as Folklorico dancers from Pioneer High School in Whittier. Probation Department staff volunteered time mentoring youth residing at Camps Afflerbaugh, Vernon Kilpatrick, Miller, Rockey, Louis Routh and Scudder.

Probation Department staff also participated in activities outside the camp and hall infrastructure. Staff helped out at Griffin Avenue Elementary School's "Career Day;" assisted with spring cleaning at the Carson Senior Citizen Group & Downtown Women's Center; donated clothing to the Midnight Mission; and delivered "Sunshine" greeting cards designed by the juvenile hall boys and girls to the Community Health Center in Downey.

Chávez Week culminated at the Museum of Latin American Art in Long Beach on March 31. The event showcased the visual and literary works of youth associated with the Probation Department, as well as other at-risk youth who participated in this year's César E. Chávez Youth Arts Program. The artwork also was on display at the annual Chávez Walk and Festival held at Olvera Street on Saturday, March 27.

"It was such a delight to view all the original artwork created by youth associated with the County," Molina said. "It's a testament to the inspirational nature of Chávez' life."

## **County Launches Bioterrorism Preparedness Awareness Campaign**

Department of Health Services' officials want the public to be aware of what they can do to prepare for a bioterrorism or other public health emergency.

"It doesn't require expensive equipment or medications," said Jonathan Fielding, M.D., M.P.H., Director of Public Health and Health Officer. "The public needs to know that being prepared for bioterrorism means having a plan and basic emergency supplies that we should all have in place living in southern California where earthquakes are common."

The Bioterrorism Preparedness Awareness Campaign features billboards and radio ads and are part of the County's Bioterrorism Preparedness and Response Program funded through a grant from the Centers for Disease Control and Prevention.

"There are concrete basic emergency preparedness activities that the public can undertake that are important for all public health emergencies including bioterrorism," Dr. Fielding said. "Undertaking some basic preparatory activities now, can help reduce fear and panic in the event of an actual bioterrorism or other public health emergency."

In addition to encouraging the public to prepare, the department is conducting its own preparedness activities. "Increasing laboratory, disease surveillance and public health emergency response capacity has been the focus of this program since its inception in 1999," said Sharon Grigsby, M.B.A., Executive Director of the Department's Bioterrorism Preparedness and Response Program. "Staff has been trained and health professionals Countywide have received education to help prepare to respond should a bioterrorism emergency occur. It's important for the residents of Los Angeles County to know that keeping them safe and healthy is our full time job."

The public has an important role by preparing as they would for any emergency or disaster. The Health

Department recommends the public prepare as they would for an earthquake or other emergency. This includes:

- Having enough supplies for each member of the household for at least three days.
- Having a plan to contact all family members if something happens during the workday.
- In the event of an emergency, monitor the news media for instructions or information from health and safety officials.

Supplies should include:

- 3-day supply of water (1 gallon per person per day for drinking and hand washing)
- 3-day supply of food, such as dried or canned foods
- Can opener
- 1 change of clothes and shoes for each person



- 1 blanket or sleeping bag for each person
- First aid kit which includes your family's prescribed medicines
- Battery-powered radio, flashlight, extra batteries, and waterproof matches
- Soap, toilet paper and extra plastic bags
- Any special items for infant, elderly, or disabled family members
- Extra pair of eyeglasses
- Copy of important family papers in a fireproof container

### Northrop Grumman Manufacturing Center Dedication

Supervisor Zev Yaroslavsky honored Dr. David G. Lynch, "father of the Hemispherical Resonator Gyro (HRG)," a sophisticated high-performance spacecraft and missile guidance navigational instrument, at Northrop Grumman Corporation's Navigation Systems Division dedication of its new HRG manufacturing center in Woodland Hills. Northrop relocated the facility from Goleta, near Santa Barbara, to consolidate Division operations in Woodland Hills where the Division, with nearly 2,000 employees, is headquartered. Company officials noted that this gyro, capable of sensing minute changes in vibration patterns on a thin-walled glass shell to gauge its movement, supports long-term space missions in applications including communications, earth sciences studies and deep space exploration.

Supplies should be kept in sturdy and easy-to-carry containers (e.g. backpacks, duffle bags or covered trash containers) and stored in a place that is easy to get to during an emergency or a disaster.

Visiting the Los Angeles Memorial Coliseum to kick off the County's "Healthy Parks" campaign, Supervisor Zev Yaroslavsky is joined by Supervisor Yvonne Brathwaite Burke and Stan Lee, Parks and Recreation Commissioner for Supervisor Burke's Second District and a member of the Board of Directors for the County's Parks Foundation. The Board of Supervisors declared April as "Healthy Parks Month" as part of an effort to raise awareness of the role that parks and their community partners play in reducing childhood obesity and promoting health and fitness activities. Supervisor Yaroslavsky noted that the County's most recent Health Survey last year found that more than half of the adults and children surveyed in a random sample of some 14,000 respondents

considered themselves obese or overweight. County health officials say that combined public and private health care spending in the County related to obesity has grown to nearly 10% of total health care costs, a rate comparable to tobacco-related health care expenses. Obesity is one of the fastest growing health problems among the County's youth, while the incidence of Type 2 diabetes, historically associated with middle aged adults, has also been rising among County teens. ## Chief P. Michael Freeman: Celebrating 15 Years of Service

Fifteen years ago, P. Michael Freeman became the eighth Fire Chief of the Los Angeles County Fire Department (LACoFD). Following a national recruitment and selection effort, the Board of Supervisors appointed Chief Freeman as County Forester and Fire Warden at its meeting held on December 20, 1988. From the moment he was sworn in, he embarked on his mission to manage the massive Fire Department and position it as a front-runner fire agency in the nation.

In the past 15 years, LACoFD's growth has paralleled the region's burgeoning population of the 1990s, increasing its ranks from 2,800 to almost 4,000 employees. Nine new fire stations have been constructed and seven contract cities have joined the Consolidated Fire Protection District since 1989. Six additional fire stations are in development. His visionary leadership is evident in many major Department achievements, including the development of several specialized emergency response and community services programs. The Urban Search and Rescue and Hazardous Materials Task Forces, the 1996 creation of a Terrorism Response Section, and the successful merger of the County's Lifeguard and Health Hazardous Materials operations into LACoFD are just a few. In 1994, air attack capability for wildland fires increased with use of contracted Superscooper airplanes and again in 2001, with the purchase of two Sikorsky Firehawk helicopters, crediting LACoFD as the first fire department in the nation to be equipped with this multi-mission, firefighting version of the U.S. military's Blackhawk helicopter.



As CEO, he has faced many financial challenges in managing the Department's growth during dynamic economic times. Perhaps his greatest challenge and success was the passage of Proposition E in 1997. Within 60 days, Chief Freeman and the International Association of Fire Fighters (IAFF) Local 1014 launched and passed, by a 77 percent vote, a massive public appeal to approve a special tax to prevent 20 fire stations from closure and a reduction in service levels.

Following the September 11 terrorist attacks and the formation of the federal government's Department of Homeland Security, Chief Freeman was appointed to several national committees to help address the country's heightened security issues, including the President's Senior



## Supervisor Antonovich Salutes Los Angeles County's Guard and Reserve Members

At the Board of Supervisors meeting on Tuesday, March 23, Supervisor Michael D. Antonovich acknowledged and thanked County of Los Angeles employees who serve our country as guard and reserve members.

Forty-five employees representing 20 different County departments and all branches of military services attended the Board meeting and were met with a 30-second ovation after they were introduced. There are nearly 800 County employees who are reservists standing ready to serve, and 91 that are currently serving on active duty to fight the war on terrorism at home and abroad. More than 1 million Americans serve in the guard and reserve forces, representing one half of our total military forces.

When called to active duty, these citizen soldiers put their civilian careers on hold to preserve our freedom. The County of Los Angeles is committed to supporting its employees who are called up for active duty by guaranteeing return to employment, providing differential pay and allowing continued accrual of sick and vacation time during deployments as provided by County ordinance.

Unfortunately, for many guard and reserve soldiers, employers are not so generous or understanding of both federal law protecting soldiers and the critical role our reservists play in national security. The National Committee for Employer Support of the Guard and Reserve (ESGR) was established in 1972 by Presidential proclamation to address these issues. An agency of the Department of Defense, the ESGR relies upon a volunteer force of 4,000



representatives nationwide to educate employers on the rights of reservists as outlined in the Uniformed Services Employment and Re-Employment Act.

On March 16, the Board of Supervisors adopted a motion commending the ESGR for their efforts and agreed to sign the organization's "Statement of Support." Rear Admiral David Janes, National Chair of the ESGR, *pictured with Supervisor Antonovich and Colonel Joseph N. Smith, Director, Military & Veterans Affairs* attended the Board meeting to celebrate the signing.
